# Improvement of the Integrated Solid Waste Management System of the city of Bacalod (Philippines)

The FEV Committee of 10.11.05 has agreed on the approval of a grant to the City Government of Bacolod for an amount of up to 220.000 euro from the FEV (Feasibility Studies Financing Facility) to finance the Study on «Improvement of the Integrated Solid Waste Management System of the city of Bacolod in Phillippines.

The main object of the Study is to comply with the provisions established under Republic Act 2003 on Solid Waste Management System, which specifically require all local government units to cease operations of controlled dumpsites and operate only Sanitary Landfills by the end of 2006, and will include the preparation of the Terms of Reference and Tender Documents necessary to pursue the public bidding for the design and construction of the proposed facility by a qualified contractor.

A summary of the required content of the Study is attached as Annex 1.

The period for the realisation of the Study is estimated at 8 months.

The City Government of Bacolod invites Spanish eligible consultants (either consulting firms or individual consultants) to state their interest in providing the required services. Interested consultants must provide information indicating that they are qualified to perform the services, in particular:

The City Government of Bacolod will select, from the received expressions of interest, a short list of consultants, following the evaluation criteria set out in Annex 2. The short list must obtain the «no objection» from the General Directorate for Trade and Investment of the State Secretariat for Tourism and Trade.
