Multiformity in Spanish boards of directors

Abstract: Corporate governance, and more specifically the structure of large corporations' boards of directors, varies substantially from one company to another, in keeping with the adage that «one size doesn't fit all». A sample of 171 Spanish companies listed between 2004 and 2007 confirmed the existence of substantial diversity in corporate board of directors size and membership in Spain. The significance of certain structural factors (size, years in business, ownership and industry) as possible determinants of the variety observed are analyzed in this article.

Analytical perspectives for customer value creation in buyer-seller relationships. An empirical study

Abstract: This article reviews the literature on customer value, in light of the diversity of definitions and the complexity and ambiguity of the term itself. It also verifies a scale to measure customer value creation, justified on the grounds of the perspective adopted. The data analyzed were taken from a sample of 181 manufacturer-distributor pairs. The empirical results revealed the utility of a scale of this nature for manufacturers, particularly as a tool for measuring the value created for their distributors.

The questions for the future relate to the course that the new Spanish economy should take: will the country continue to be a significant host for immigration? Immigration and unemployment in Spain: impact of the economic crisis

Abstract: The economic crisis has raised Spanish unemployment rates substantially as a result of both stymied job creation and increased layoffs. Empirical evidence shows that job loss is particularly severe among the foreign population. The present article defines the theoretical factors that lead to job loss by a specific individual. On those grounds, it analyzes whether the crisis has had a differential impact on Spaniards and non-Spaniards or, on the contrary, the apparent higher impact of the recession is justified by the immigrant population's labour and socio-demographic characteristics.

Immigration and welfare: a case study of Spain

Abstract: This article reviews the relations between the welfare state and immigration, with particular attention to three issues: the possible «drawing power» of social benefits, access to cash and health benefits by immigrants compared to non-immigrants and the role of immigration in the sustainability of the welfare state in a context of a rising rate of demographic dependence. The estimates for Spain in 2007 show that immigrants tended to access social benefits less assiduously than the native population.

Unemployment cover for immigrants
