# The Future of Pensions in Spain: Prospects and Lessons

**Abstract:** The financial sustainability of pension systems is under debate in Europe in general as well as in Spain. European governments must tackle the problem and citizens must be adequately informed to enable them to take their own decisions and adapt to the changes. The first part of this article reviews the chief results of the various studies that analyse pension spending in Spain. The general conclusion is that due to population ageing, contributory (defined benefit) pension spending will reach barely sustainable levels in the decades to come, although no consensus has been reached about the size of the deficit. The second part of the paper analyses how productivity gains are transferred to pensions and, more specifically, the effect of the mean pension/mean productivity ratio.

# Wage Differences in the Spanish Manufacturing Industry: Estimation and Explanatory Factors

**Abstract:** This article aims to estimate the relative influence of different sources of wage dispersion in a selected group of manufacturing industries. ANOVA techniques were used to break the variance down into four factors: general training, specific training, discrimination and establishment. The statistics used were taken from the National Statistics Institute's Wage Structure Survey. Among the most prominent findings was that in all the samples analysed the establishment factor contributed most to explaining remuneration. It may therefore be inferred that non-competitive factors have a role in the wage setting process.

## Impact of the New Liquid Fuel Tax on Revenues: A Regional Analysis

**Abstract:** Under the new tax on retail sales of certain hydrocarbons that came into effect in Spain in January 2002, the revenues are assigned to the autonomous regions. The resources obtained with this new tax device will be primarily earmarked to finance health care expenses. The purpose of the present paper is to evaluate the effect on revenues, for which microsimulation techniques are used. The results indicate that the new tax raises combined VAT and excise duty revenues by 1.2849 per cent. It is likewise found that the increase in resources to enhance health care are not distributed evenly across the various autonomous regions.
